1) Treasurers Report - There was no report because Bob Ferguson was not here.

2) President's Report (Len Kortekaas)

Nominations for next year are complete except for the position of Secretary. Len is willing to serve another 2 years as President. The reactions to the first Spring Tour were very positive. One suggestion was to skip the tour of the Old Second Bank. One problem was how to handle changing the couple who did not show up because their luncheon was paid for on the first tour. They will go on the second tour. A motion was made by Reinhard Taylor, seconded by Liz White, that we should charge them \$22.50 to cover the cost of missed meals. This motion passed.

3) Unit 90 Schedule for 2011 (Len Kortekaas)

Communications (Bill McCauley)

With different groups having different colors, there is some confusion.

Information Services. (Rich Chierico)

Rich feels strongly that this committee should be separate from the Membership Benefits Committee.

Legislative (Jesse Macro and Bob Lyons)

Jesse will attend the next meeting of the Legislative Committee. Bob Lyons pointed out that Bob Haisman, former IEA President, is apt to use an alarmist approach to pension issues. Bob further commented that a bill is being drafted in Springfield like the Tom Cross Bill in which current teachers will have a choice among a 20% contribution, tier 2 9.4% or a 401 K plan where the teacher will pay 6% and the school district will also pay 6%. All benefits up to this point will not be changed. This proposal will lead to law suits. Bob does not think such a bill will pass because of an unfavorable reaction of the general public. This will not be a 24-hour deal. Finally, Bob feels that the IEA made it clear to Governor Quinn not to sign such legislation.
