#### 8) Legislative (Bob L./ Jesse M.)

Strongly suggested that schools and universities pick up a large percentage of the funding shortfall. This would be through increased property taxes. So, what Tom Cross is suggestion is a "billion dollar" property tax increase. No way this would fly. Three possibilities:

- A. COLA for retired people. It is done in other states.
- B. Tax pensions and annuities. Everyone is taxed and it would go into the General Funding.
- C. Other state employees would pay more as some pay less.

The key focus is the "constitutionality" of state funding. The IEA

and IFT would go to court and this would lead to a waste of money. What both the IEA and IFT agree upon is that a necessary change is needed but must be "affordably the State. What must be continually monitored is the State playing one group against the other. Ten ways to pay the need for novel ideas were such as: State could amend tax structure to become a Gradated Income Tax program or, increase the number of Casinos in Chicago!

Key to this issue of funding through taxation is the forthcoming election in November. (On a recent WTTW program addressing the Governor's proposal on two large issues, Pensions and Prisons, overall idea was a wait-and-see what comes out of the November elections.)
