Mayor Emanuel will raise taxes and try to reduce pension benefits. Chicago may serve as a preview of our pension situation. There is a question of who will endorse Governor Quinn. The unions will have to work for Quinn with enthusiasm. If Rauner wins he will have to deal with a Democrat legislature. Maybe he can accomplish some things. He will push for charter schools. The 3% millionaires tax is Madigan's attempt to raise funds. Finally, a person like Rauner may be a factor in influencing the Black vote in Chicago.
