8) Legislative (Karl Gabbey)

- 1. Voter Voice will send info about legislation. Please sign up at IRTA website.

- 3. IRTA was instrumental in saving TRIP, bill was defeated by 3 votes
- 4. Tier 3 is worst bill ever. It is another way to cut pensions. Includes a private plan option. It has passed, but has no rules yet. Passed as part of the budget bill. Part of Rauner veto of bill that allowed public subsidies of private schools.
- 5. IRTA PAC gives to candidates who support our issues. It asks \$12 per year, which is constant source of money, so they can plan spending. Only about 1/7 of members do this. Help us help ourselves. Legislative accomplishments are going out in the newsletter on a regular basis.
- 6. Proactive PAC ---- Reactive Defense Fund
- 7. Rauner has plan to go over state constitution to line item veto what he thinks is too expensive. Asking for special dispensation from Congress to do so. Hopefully will not pass muster.

9) TRS (Bob Lyons)

TRS deficit is \$4 million over last year. State billing feds for large amount. Dold tried to get money from local school districts. Returned to state for \$61 million. Unfunded continues to grow faster, even though TRS has done well with investments. Since 2010 fiscal year, have had positive returns. In comparison to other pensions in US have had more money in real estate and alternate investments, so we were really hurt in 08-09. Unofficially funded about 40%.
