Bob read Karl's report. New law allows retirees to re-enter TRIP during enrollment period. Rauner vetoed bill that changed minimum salary from 9,000 to 40,000 in the State of Illinois. Union leaders are concerned about Illinois Policy Institute campaign attempting to coerce members to drop membership.

## 8) TRS Report (Bob Lyons)

Reported earnings from fiscal year assets grew from \$49 billion to \$51.5 billion. Bob reminded us that spouses receive 50% of deceased members pensions.
