Bob Lyons said that four candidates will be at breakfast, endorsed by state, can be different by unit if decided by the Executive Board. List of state endorsements was handed out at board meeting fro the state IRTA. Discussion ensued about order of events at the legislative breakfast. Short opening followed by questions, if time permits. We expect eight candidates each getting two minutes each. They will receive questions to review before the breakfast.

Karl Heinz-Gabbey said that Bill 3046 passed and approved by Governor, but money has not been freed up as of meeting. Opt in/ Opt out starts October 15, ends in early December. Enrollment period starts Dec. 1 and lasts till March. (see newsletter for more details.)

Governor race is ugly. Graduated tax income plan did not pass last time it was proposed. It would add money to pension and state funds. Windfall provision was brought up by Bob Pinkerton. Up to 1983, we were allowed to get Social Security and other pensions. Medicare is not always the same plan. Read information delivered from the government. TRS keeps record of all phone calls so you won't get different responses to same questions.
