- Madigan elected Speaker of the House
- Cullerton elected President of the Senate
- McSweeney offered resolution **not** to tax retirement income
- Still big debt from Rauner and backlog of bills payable
- Tony Smith no longer ISBE State Superintendent

#### 8. TRS (Bob Lyons)

Bob reported on impact of mounting debt in pension plan. Pointed out simple to compounded interest with no additional funding. Continued underfunding on the part of the state. Impact of lower interest rate of inflation as compared to 6%+ for 20 years.

Bob also stated about IEA and IFT decisions protecting current teachers vs. the interests of retired teachers to agree to diminishments in order to pass ERO. Every dollar we did not receive in our fund costs \$3 in the future. Bob referenced former IEA president and current candidate for TRS annuitant open position, Cinda Klickna voted in support as an active trustee of the ERO "deal." IEA would like the retired annuitant seat. They have endorsed her. Remember, **Doug Strand** from the Quad cities a long time retired member of the IRTA **is our endorsed candidate**.
