GPO/WEP: IRTA LAWSUIT

The IRTA recently hired a law firm to review the constitutionality of two federal provisions: GPO(Government Pension Offset) and WEP (Windfall Elimination Provision). However, the recently rendered legal opinion was that such a lawsuit would have very little chance of succeeding on a constitutionally-challenged basis. Therefore, the IRTA will now focus its efforts to change the GPO/WEP provisions through congressional action.

GPO/WEP: IRTA CALL to ACTION

"A resolution has been introduced in the House of Representatives (H. Res. 987) to immediately consider the Social Security Fairness Act (H.R. 147) that repeals the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) penalties. H. Res. 987 is a discharge petition. The introduction of this bill is a procedural maneuver to force a vote on the Social Security Fairness Act. Currently, H. Res. 987 has 120 signatures of the 218 needed. IRTA would like to urge its members to contact your Congressman's office and urge them to sign the discharge petition, H. Res. 987. Your Congressman must sign this petition before NOVEMBER 13, so be sure to act quickly.

The following is an example of what you should say to the person who answers the phone: As Congressman______'s constituent, I am calling to ask him/her to sign the discharge petition, House Resolution 987, introduced on September 7, to bring the Social Security Fairness Act (H.R. 147) to a prompt vote on the House floor."

TRS REPORT: BOB LYONS

Here's a message from Bob Lyons, the second-elected annuitant to the TRS (Teacher Retirement System) Board of Directors:

Stuart Levine, one-time appointed member to the TRS Board of Directors, is scheduled to stand up in Federal District Court on Friday, October 27, 2006, and to plead guilty on multiple counts of extortion, kick-backs, and corruption concerning his actions while serving on our TRS Board and another state board.

As of this date, Monday, October 23rd, no regular employee of TRS has been named as part of the conspiracy, and there is no evidence that TRS lost any money because of Levine's actions.

"Information provided by TRS was significant in the investigative results achieved to date, and the TRS Board and staff look forward to the day when justice will be served."

Good News: The TRS fund for the first time has passed the \$38 billion mark, due to prudent investment decisions.
