### **ACTION ALERT: WRITE A LETTER**

One of the legislative goals of the IRTA is the passage of an ad hoc increase for TRS annuitants who retired prior to 1980. Due to opposition from leadership, this legislation has been held up in Executive Committee. IRTA is urging its members to write their Illinois legislators and to ask them to consider passing an ad hoc increase if there is increased funding for the pension systems. A SAMPLE LETTER follows:

Dear Senator\_\_\_\_\_or Representative\_\_\_\_\_,

I am a member of the Illinois Retired Teachers Association. an organization of retired educators with over 31,000 members. I am writing to ask you to support an ad hoc increase for annuitants and survivors of the Teachers' Retirement System of the State of Illinois who retired before 1980.

This would provide a pension increase to those annuitants and survivors who retired in pre-inflationary years. Some of these individuals retired over 30 years ago and can barely get by on the small pensions they receive. Additionally, many of these retired educators do not receive Social Security. An ad hoc increase for these retired educators would help improve their quality of life

I am aware that the ad hoc increase would create additional unfunded liability for the pension system. That is why I am asking you to support or initiate an ad hoc increase if the General Assembly passes legislation which would provide additional funding for the TRS pension system (i.e. pension obligation bonds).

#### What Will Happen With the Governor's Proposal? (excerpts) by Bob Lyons

NOTE: Bob's comments on the Governor's 2007 General Revenue Tax Proposal are his own personal opinion and certainly do not represent the position of the TRS or the IRTA.

Governor Blagojevich's gross receipts tax proposal and his tax on business to back his health care plan have been called not just the largest tax increase ever presented in Illinois, but in the nation, and, while I don't know if that is really true, I think we can all agree that it is large and that it has far-reaching implications. Will it happen? Well, since it is already evolving, it would be easy to predict that whatever eventually does pass, the legislation will look different than what was originally proposed.

What is important is that the legislature is now not talking about should there be a proposal to increase revenue, but what form that proposal will take. For Springfield that is a significant change. At this date (April 16, 2007), the Governor's only allies appear to be the IEA, the IFT, AFSCME, and Senate President Emil Jones, because they all see his proposal as a way to significantly increase state money for education.

Where do we fit into this proposal? Governor Blagojevich has asked to be able to sell \$16 billion more in Pension Obligation Bonds and to lease the state lottery to possibly gain as much as an additional \$10 billion, and then the total of \$26 billion would be given to the five pension funds and result in reducing the unfunded liability of the state pension system by over 60%. The TRS share could be about \$14 billion, and the TRS funded ratio would increase from over 62% to about 83%.

If the alternative is that the state can not afford to give us the increase in funding that is required and would even be hard pressed to give us what we got last year, then the Governor's proposal would certainly be better than that. Of course, as part of his plan the state contributions to the pension plans thereafter would be so small that it would take us 33 years to grow from 83% to 90% fully funded by 2040.

We have done very well with the POB's sold in 2003, we are making money with that money, but we have also had the state contribute \$500 million less each year as the interest is paid on those bonds.

As I understand it, the Governor's office believes that it is possible to borrow your way out of debt. Certainly it has been tried before. And again the alternative is that if we do not get the money from the state this way, I do not know how we will get the money from the state. Between the two, I would see the POB's as more likely than the lease of the lottery.
