LEGISLATIVE UPDATE: JIM BACHMAN, IRTA EXECUTIVE DIRECTOR

On Friday, July 20,2007, Jim Bachman, released the following legislative update:

"Last week the Director of TRS (Jon Bauman) presented testimony to the House of Representatives (Committee of the Whole) on three different occasions. The Committee of the Whole is used for information gathering purposes. Director Bauman provided testimony on investments, future bonding and leasing the lottery. For the most part he was well received. At this time it doesn't seem the House is inclined to pass either proposal (bonding or lottery leasing). Speaker Madigan said this week that he did not have the votes to increase gaming. The leaders

have eliminated the big money producing items. The Governor is now talking about increasing cigarette sales tax and nursing home bed tax. President Jones said yesterday (7/19/07) that he believes they will pass a budget next week for the rest of the fiscal year. A lot of hard work will have to happen for that to come to fruition. Full pension funding looks to be on the right path. I will keep you informed."

PRIMARY ELECTION: NEW DATE

The new primary election date in Illinois is February 5, 2008. Therefore, candidates for state and federal offices will need to start circulating their petitions by August 7, 2007. Volunteer to help the candidates by circulating their petitions among your friends and neighbors. As retired teachers, we ask these elected officials to support our issues, and this is an opportunity for us to do something for them that they will long remember.

TRS REPORT: Bob Lyons

The Teachers Retirement System (TRS) began the past fiscal year with \$36.6 billion in its pension fund, which was 62% fully funded. At the end of the fiscal year (6/30/07) the pension fund had a preliminary estimated value of over \$41 billion with the possibility of being 69% fully funded. Due to the excellent return rate on the various TRS investments, the pension fund grew - despite the need to sell \$1.2 billion in TRS assets in order to meet its obligations during the fiscal year.

In order to balance its own budget, the State of Illinois has departed from the 1995 funding law for the last two fiscal years at a cost to TRS of over \$1.1 billion in pension funding. However, TRS is expecting the state to return to the 1995 funding schedule. The Legislature and the Governor agreed to fund the TRS pension system at the 1995 level for the one-month budget for July, while the overtime session negotiations continue. While that agreement is a good sign, it is by no means a guarantee that TRS will receive the \$1,041 million that is called for and promised to TRS.

It is entirely possible that by the time you read this report the Legislature and the Governor may have finally agreed on a balanced budget (without shorting the pension funds). However, each one of you can still play a role in protecting the TRS pension fund. Contact your legislators and

tell them you want their assurances that the state will contribute its mandated share to the TRS pension fund. The State needs to do its part.
