IRTA 2008 LEGISLATIVE GOALS

The Legislative Committee of IRTA at its January 22, 2008 meeting discussed the following goals (State and Federal) for 2008:

- 1. Oppose the referendum to call a 2008 Constitutional Convention for the State of Illinois **VOTE NO IN NOVEMBER** on this referendum.
- 2. The General Assembly honor its funding obligation as found in law.
- 3. Oppose changes resulting in decreased benefits to TRIP members.
- 4. Support and organize a "Get Out the Vote" campaign for the IRTA membership.
- 5. Continue to support legislation that provides an ad hoc increase for those members retired prior to January 1, 1980 provided funding becomes available.
- 6. Monitor proposed governance changes of TRS fund and board.
- 7. Monitor and inform members on consumer fraud legislation.

The Federal Legislative Goal is: Support repeal or amendment of GPO/WEP

FISCAL YEAR 2009 STATE BUDGET BOB LYONS – ELECTED ANNUITANT – TRS BOARD

Professional film critics will tell you that it is not a good sign when a new movie is not made available for previews. For the first time since Dan Walker was our governor, the executive branch did not brief the legislature prior to the Governor's speech, and the materials given out before he spoke to the legislators and the press were incomplete and had errors. Listening to Blagojevich's address to the legislators, as I was driving down to Springfield, I was surprised that he never mentioned anything about pensions or POBs (pension obligation bonds). It was not until the press and legislators were discussing the speech afterwards that I learned that the Governor is proposing the sale of \$16 billion in new debt to fund the pensions and reduce the unfunded liability. For the last several years the proposals made by Governor Blagojevich have not come to pass and that may be the case this time as well, but we have to take them seriously.

In 2003, Blagojevich in order to balance his first state budget with the cooperation of the legislature had the state sell \$10 billion in pension obligation bonds. The state kept \$2.7 billion to pay the first year interest and to reimburse itself for prior payments to the pensions and gave the five pension funds \$7.3 billion with TRS receiving \$4.3 billion. It was a good year to sell bonds and the interest rate was only 5.05%. Though the director of the budget wanted us to put the proceeds from the sale in fixed income investments, TRS put the money into the same kind of investments as the rest of our money and we did very well with the POB funds growing it by 67% in the first four years. Of course we are paying back the money with interest that we received from the state by reduced payments to the system, but we are ahead and so is the state. The problem in returning to POBs as a solution to the state's difficulty in meeting its funding obligations to the pension systems is the very real concern that this may not be an opportune time to receive billions of new dollars to invest. Fully expecting that the Fed will continue to reduce interest rates in its hopes to stimulate the economy ought to mean the POBs could be sold for a low interest rate, but it also might mean that they might not be easy to sell. And for us the more significant question would be will the bottom of the market be reached by this summer? If we had received seven or eight billion in new money last summer, depending on where we had invested it, we very likely may not have seen it grow, given the recent market conditions.

The fiscal year 2008 contribution of \$1,041 million from the state was the first time in three years that the system received its certified funding and that was because the state legislature voted for that amount. The fiscal year 2009 certification requires a state contribution of \$1,451 million, and increase of \$410 million. While my personal preference would be to continue on with the current funding plan, that may not be the alternative the Governor and the legislature will choose and it is not now what is in the 2009 budget. I will continue to keep you and other annuitants updated through my regular e-mails. Otherwise, watch the news from Springfield.

ADDRESS LABELS

The address labels on the front of the newsletter show your status as a local member and as a state member. Local Dec 08 means that you have paid your local membership through December of 2008. The State membership has the following code: A is annual + current year;

D is automatic deduct + start year; L is Life + start year; Y is 5-year membership + end year.


