TRS Report – AUGUST. 2008

"Politicians are not famous for facing up to reality and making tough decisions, and of course our current Governor and legislature have done everything possible to carry out that standard to a new high, or should I say low. This year they were even unable to agree on any gimmicks or one time tricks to create needed additional revenue, so that in the end, the Illinois Senate and House agreed to give the Governor an unbalanced budget with possibly more than a \$2 billion hole in it and left town. In doing so, they ignored the fact that the Illinois constitution clearly requires the state budget to be balanced. The Governor responded with drastic cuts to a variety of needed human services, hoping that an aroused public, or at least subsets of the population of the poor, aged, and disabled and those that serve them would be so angered and energized that they would pressure the legislators to go along with some of the Governor's ideas, such as more Pension Obligation Bonds, to increase revenue, restore the cuts, balance the budget and even add capital spending. Unfortunately for the Governor and his plan, the House wound up doing nothing and the Senate did not even come back to Springfield. As a result some time in the next fiscal year the state will run out of money, but since that will be some time after the election in November that was considered an acceptable course of action, or more accurately inaction.

For TRS, we did not want to try Pension Obligation Bonds again fearing that a huge infusion of capital at this time, given the conditions of the market, would have been difficult, if not impossible, to invest in assets that could have promised a positive return. We wanted, and will get the money that we should, for this next fiscal year and over time we will be able to take the necessary steps to put those funds in asset classes that are giving us some comfort in an overall down market. Remember that US equities are down by 14% and global equities have fallen almost 20% and that is why a pension fund like ours has diversified into alternative investments, such as real estate, private equities, and funds that are designed to protect you in a down market. Though only a month into the fiscal year we are still totaling our gains in all three of those categories, and we have already reduced our loss for the year to under 4%. And sad to say, that is good."
