IRTA 2009 LEGISLATIVE GOALS

The Legislative Committee of IRTA at its January 21, 2009 meeting discussed the following goals (State and Federal) for 2009:

- 1. Support FY2010 appropriation that requires the state to honor its pension funding as found in law.
- 2. Oppose changes resulting in decreased benefits to TRIP members.
- 3. Support legislation that provides an ad hoc increase for those members retired prior to January 1, 1980 provided funding becomes available.
- 4. Monitor proposed governance changes to TRS fund and board.
- 5. Monitor consumer fraud and fair credit practice legislation.
- 6. Review and/or revise endorsement process of candidates.
- 7. Advocate repeal or amendment of Government Pension Offset (GPO) and Windfall Elimination Provision (WEP).

VOLUNTEERS NEEDED

The American Red Cross has contacted Unit 90 to help disseminate information regarding their volunteer program. In the Greater Chicago area alone there are about 3,000 active volunteers but the need for new people is ongoing. Volunteers are needed in instructing courses, providing office support, assisting with disaster response, etc. We often hear of the Red Cross response to major disasters, but the Red Cross is also one of the first groups on the scene at local disasters such as house fires, floods, heat waves and winter storms. They run large-scale community education programs including Kid Firestopper, Whale Tales (water safety) and CPR training days. The Red Cross provides training for all volunteer positions and specifically mentioned the need for instructors in their community education programs. TRS REPORT by Bob Lyons, Elected Annuitant, TRS Board

Two years ago following an investment study the TRS Board made the decision to reduce our exposures to equities, especially U.S. stocks. Instead we invested in new assets that do well in a down market, such as commodities, and made other investments that typically perform well during periods of inflation.

When the prevailing sentiment in the market turned last year, we did see favorable returns from our managers that had positions in energy and other commodities, but that still did not save us from a loss in the fund of 5% for Fiscal Year 08. It was our first negative return in six years and only the fourth in the last 30 years. Unfortunately far worse was ahead for us and for the worldwide economy.

The collapse of the housing market, the subprime loan mess, and then the financial institutions meltdown has resulted in what is now called the worst economic crisis since the Great Depression. Not only U.S. stocks went down, but international equities as well. Bonds of most all types were not a refuge and even commodities were pulled down by a worldwide decline in demand. TRS lost 11 percent of its portfolio during October 2008 alone, one of the most volatile periods in the history of the financial market. And the market has continued to decline, and with the exception of some Treasury notes and gold, diversity in investments has been of little value. From July 1, starting with \$38.4 billion the value of our fund fell to \$29.1 billion, a decline of 24%, by December 31, 2008.

While that is the reality of our fund, it is equally certain that all of our pensions will continue to be paid. We have seen the fund reduced by billions, but billions remain, and the obligation of the State of Illinois to see that we receive our pensions remains and is guaranteed by both the State and Federal Constitutions. In time the markets will turn and we are taking steps now to prepare for the recovery, but it is going to take time.


