#### TRS Report – AUGUST 2009

Professor Paul Green of Roosevelt University claims that members of the Illinois General Assembly have developed great skill in following a problem-solving method called the three D's: deny, delay, and defer. Deny that there is a problem for as long as you can, then delay dealing with it, and hopefully defer any tough votes until later. Any vote that could alienate a significant portion of the populace has to be avoided.

All of that to explain how and why the General Assembly finally passed a state budget without an increase in the state income tax two weeks into the fiscal year that was immediately signed by the Governor. Not only is the budget not balanced, but it calls for such creative accounting ploys as "borrowing" \$3.5 billion from state vendors by putting off paying them until after the end of the fiscal year in June 2010. Another billion dollars or so will be stripped from the various state funds, but fortunately not our health insurance fund. The good news for TRS is that the plan also calls for the State to sell \$3.47 billion in bonds at possibly as low as 3.5% interest which the state will have to pay off in five years. This money will be used to fund the pension systems. TRS will receive the amount certified by our actuaries of \$2.1 billion and the State University Retirement System and the Illinois State Board of Investments that covers state employees, judges, and legislators will gain the rest. TRS will receive our full amount as soon as the bonds are sold and it will be the responsibility of the state to pay them back. Good news for pension funds, but it means the state is using short-term borrowing to pay long term debt. Of course the need to balance the 2011 budget will be much more difficult to achieve.

I had really hoped that TRS was going to be able to end the fiscal year at or above \$30 billion, but even though we are still waiting on new real estate appraisal numbers there is no reason to think that these figures will boost us significantly above our preliminary number as of June 30 of \$29.15 billion. We started the 2009 Fiscal Year at \$38.4 billion and 56% funded and now down to \$29.15 billion we would be at 40%. Our loss came to 24% and puts us in between the California Public Employees' Retirement System that dropped 23.4% and the California State Teachers' Retirement System with a decline of 25%. Larger funds their combined total loses for the year came to \$99.6 billion. Fortunately with the market up the last several weeks the numbers for late-July now put TRS over \$30 billion. Let's hope that FY 2010 will indeed be a year of recovery.

There is a saying that no idea ever truly goes away in Springfield, especially if it is a bad idea. Governor Quinn's original proposal for a two-tiered pension never came to a vote in May due to a lack of support. However, the Governor established a Pension Modernization Commission compromised of representatives of all interested parties, including the teacher unions and the IRTA, with a date of early November to issue a report to the General Assembly. I will tell you there is support on both sides of the political aisle to reduce the costs of pensions in the future. Even with the opposition of advocates of education and educators there is considerable risk that there will be a new and inferior pension program for teachers who are hired in 2010. If you know someone who is a college graduate who doesn't have a teaching certificate, or who is currently teaching in a private school, but may yet want to teach in a public school in the future, urge him or her to apply to sub this fall. Even if she subs for only one day, once she has put money into the TRS fund she is locked into the current pension and assured of every benefit that we all now enjoy.
