AREA II CONFERENCE REPORT

The Area II Annual Conference was held on Monday, March 28, 2011, at the Randall Oaks Golf Club in West Dundee. Marti Swanson, the Area II Representative, introduced the three main speakers: Jim Bachman (IRTA Executive Director), Terry Link (State Senator, 30th District), and Bob Lyons (TRS board member).

Mr. Bachman discussed various legislative issues including: 1) Senate Bill 2279, which amends the Illinois Pension Code and extends the 120/600 hour employment limitation for annuitants through June 20, 2021, 2) TRIP health insurance, which will likely include a 5% increase in premiums, and 3) the IRTA PAC (Political Action Committee) donation option through pension deduction.

Senator Link talked candidly about the "difficult" and challenging times in Springfield ranging from pension system problems, fiscal/taxation issues, and re-districting of the General Assembly concerns.

Dick Ingram, the new TRS Executive Director, was introduced. Bob Lyons reviewed the status of the TRS pension system and noted that the TRS unfunded liability was created by state officials, who since the 1950's decided NOT to give TRS all of the money required to cover current and future pension obligations.

TRS Report – May 2011

For the last two fiscal years the State of Illinois has been forced to borrow the money in order to make its pension contributions, but as a direct result of the tax increase in January the State's share of the funding for this next fiscal year will come from general revenue. Friday, April 15, the Illinois Senate sent legislation to Gov. Quinn that will spend \$6.4 billion to pay the five state pension funds for FY 12 and also for the cost of its past borrowing.

In the last weeks of this legislative session you can expect to hear from both Republican and Democrat legislators that the cost of our pensions is going to require drastic cuts in many vital and necessary state programs. The two parties will disagree on how much to slash and from what part of the budget, but they will both agree that it is our fault. You can count on the Chicago Tribune, the Civic Club, and a chorus of special interests to declare us guilty of hurting state government and the people of Illinois because of our selfish "gaming of the system."

Do not accept that guilt. What did we do? It is totally undeserved because the problem faced by Illinois today comes from nothing that we did. We did not cause the problem, what we did was our job. We never decided what we would get paid; school administrators and school boards did that. We never decided what were the rules that would determine when we would retire and what our pensions would be worth; state legislators and governors decided those matters. Over the years we paid into our pension fund exactly what we were required to contribute, six percent with my first paycheck and eight percent with the last, and current teachers 9.4% But what did the state of Illinois do with its share of the agreement?

From 1953 through 2010 paid on average 56% of what TRS actuaries determined was necessary to fully fund the pensions. Illinois for all five pension funds has saved approximately \$29 billion dollars by not contributing what they should have, that \$29 billion was used by the State to pay for its other expenses to everyone's benefit. Illinois residents/taxpayers got to benefit from the use of the money that should have gone to the public pension funds. And now they want us to feel guilty. I don't think so.

If the Teachers' Retirement System and the other four pension funds had received the required funds from the State of Illinois, then the systems could have invested the funds and grown the assets. As a result of not having the money to invest, the total unfunded liability has grown to be over \$85 billion. If the State had contributed what it should have over the years, pension funding today would be a non-issue! For this current fiscal year, \$700 million of the State's payment to TRS represents "normal cost", the amount determined by the actuaries necessary to fund the pensions of current teachers. The other two thirds, over \$1.4 billion, was required to make up for what Illinois did not put into the fund in the past.

For retired teachers, for the last twenty years 49% of our pension check comes from the success of TRS investments, 22% is from the contributions paid by active teachers, 4 percent from school districts, and 25% from the State. The people of Illinois need to know that Illinois teachers and other public employees have earned their pensions and have paid their full share to ensure their retirement. Today the pension payment cost, which the State is required to make, is not high because pensions are high, but rather because – throughout the years – the State did not meet its own funding responsibilities. Don't let them make us the guilty party.
