## **TRS REPORT - AUGUST 2011**

Have you ever considered that the odds are 50 to 1 that you would teach and retire in the state with the lowest funded pension system? Yes, what I am saying is that based on the numbers from Fiscal Year 2010 the combined Illinois state pension fund system was the lowest-funded in the nation. Hopefully TRS's good investment returns for this past fiscal year may help move Illinois ahead of West Virginia once again. A year ago June 30<sup>th</sup> TRS had \$31.3 billion in the fund and the funded ratio was 40.5%, which was the best of the five state funds. The early number for the end of June, 2011 is \$37.115 billion, and it is expected it will be higher after the final audit. While showing an asset growth of 18.5%, the reality is that TRS was required to take \$1.1 billion from its own investments to make up the difference between the contributions coming in and the benefit payments going out during the year. Counting that amount as money that it earned, the TRS rate of return for FY2012 would by 22%. While the fund grew, and grew significantly, TRS is still recovering from its losses due to the 2008 recession. My estimate is that our pension fund is currently close to 44% funded.

Despite the view of the *Chicago Tribune* and the Civic Committee of the Chicago Commercial Club, the principal cause of the underfunding is not the result of "overly-generous" pensions, but that the State of Illinois has consistently underfunded the pension funds from their inception. This past spring the legislature considered changing the benefits of all current public employees in order to reduce the cost of the State's contributions to the pension systems. A strong response from both active and retired public workers discouraged them from ever bringing the legislation to a vote, but the State's goal to lower the cost of their contributions remains.

As I reported last month, the legislators who are driving the "pension reform" issue want the public employee unions to come to the table, to be a part of the process, in the hope that they can write a bill that will give the State what it wants and one the unions will accept. Frankly, I do not know if that is possible. It is very likely that if the legislation either reduces the benefits or increases the contributions of the employees, the proposed law would be ruled unconstitutional. As retired teachers, we need to know what is taking place and how whatever is proposed may affect us. For example, any proposal to move active teachers into a 401k type of plan would mean that they are no longer contributing to the pension fund. It is the responsibility of the Illinois Retired Teacher Association to keep us informed.

At the end of June state courts in Colorado and Minnesota ruled that each state has the power to reduce pension Cost of Living Adjustments for public employees who have already retired. TRS released the following statement: These two rulings have no effect on Illinois or the COLAs TRS members are expecting. The court cases only affect those two states. There is no similar court action in Illinois.

These decisions certainly could inspire an Illinois legislator to consider going after the benefits of those of us already retired, but the pension protection clause in our constitution is far stronger and more specific than what could be found in the state constitutions of Colorado and Minnesota. Also, they will not look to change retiree's pensions until the legislature has done something to reduce the costs of the pensions of current employees and the courts have determined the constitutionality of whatever measures they have taken. If the State finds that it can change the benefits of current employees, the benefits of retirees would be next. We need to remain vigilant and be ready to take action. The pension you protect is yours.
