## TRS REPORT by Bob Lyons, Elected Annuitant, TRS Board



The Illinois Supreme Court has announced it will hear oral arguments in the pension overhaul case on March 11 at 2:30pm. The 2013 law was designed to close a \$111 billion deficit in the combined pension systems by reducing benefits of active and retired teachers and other public employees. The State's argument is really quite simple. They are saying, "Based on the Illinois Constitution the State cannot cut pension benefits – unless it really needs to." That is the argument they will present to the Illinois Supreme Court.

Early on in your teacher preparation if that had been the way the pension guarantee had been explained to you, would you still have taken the job? And that is the first problem Attorney General Lisa Madigan and her people have in making this argument because that is not what teachers, university professors, and state employees were told when they were hired. All of us learned at some point in our careers that our contracts could not be abridged, and that very specifically our pension benefits could not be diminished or impaired. Period. There was no reference to "unless, of course, that we cannot afford to pay the benefits."

And since the position of the State's lawyers is not helped if it is the result of the State's own acts or failures to act that resulted in the required pension payments growing to a size greater than their existing means to pay, they will try to convince the Court that is not the State's fault. There will be no mention of the many billions of dollars Illinois should have put into the pension systems but instead spent elsewhere. The State argues in its brief that the financial credit crash and the Great Recession of 2008, a cause totally outside their control, resulted in a pension debt that threatens the State's very existence. The rather obvious difficulty in selling that explanation is that it does not fit the facts. When the Illinois Constitutional Convention identified the problem in 1970 the combined pension were funded just over 41% and as of the end of June 2014 they were at 42.9%.

Ultimately for the Illinois Supreme Court to rule in the State's favor a majority of the judges must say it is totally impossible for the State of Illinois to make its required actuarial payments to the state pension funds and thus they can cut benefits. I suppose the State could argue that since in its total history they never actually have made a full actuarial payment that that certainly proves that they cannot. But an acceptance by the Court of that argument would quickly fill the Illinois Court system with bankruptcy claimants. That you did not try to pay is hardly proof that you cannot pay. I fully expect the judges to vote 7-0 in favor of the legal concept that the pension protection clause says exactly what is written. Illinois pension benefits cannot be diminished nor impaired.

The State of Illinois Supreme Court ruled on the case regarding State retiree health insurance, Kanerva vs. Weems, last July over a year after they heard the arguments. Considering that the Illinois Supreme Court adopted a broad interpretation of the Pension Protection Clause in that suit that fully supports the interpretation advanced in our case, Heaton v. Quinn, I would hardly think the Court would need many weeks to resolve the issue in our favor given the similarities between the two cases.

The fact that you are reading this now means that you belong to the IRTA, but have you contributed to our Legal Defense Fund? More than a half of million dollars has been contributed, and we will all gain when our benefits have been made safe, but have you helped to make that happen? I hope so. **See next page.**

This meets in various locations once a week; parents can drop off young children for up to three hours where staff and volunteers provide activities and care for the children. Clearbrook's Day Program sites need volunteers during the day, evenings and weekends to assist with feeding or to participate in activities designed to enhance clients' productivity and socialization. Volunteers may accompany clients on outings or organize a cleanup/ beautification project at residential or day care locations.
