Highlights for the two day meeting included the Keynote delivered by Illinois Chief

Justice, Lloyd Karmeier, a welcome from Governor Pritzker, the Area 2 caucus, that elected Wendy Wiegers of Region 2 as Area Representative, the election of state officers, President John Flaherty, Vice-President Bill Funkhouser and Treasurer Donnie Ostrom. Bob Lyons' Report



On September 19, the North Lake Shore unit had their local legislators in to speak and answer questions. They had six legislators; both state representatives and state senators and all six were Democrats. I was there as Region 3 Director, Bob Kaplan as Area 2 Chair, and Karl Gabby as

representative of the Legislative Committee. All six of the legislators agreed that no action could be taken by the State to reduce our pensions. None of them saw any interest in taxing our pensions. They agreed that any attempt to remove the pension protection clause would fail because of court actions, both of breech of contract and ex post facto infringement. Attached is Fred Klonsky's take on the meeting, but I would disagree with him on saying that the legislators had "no plan B" if the constitutional amendment on the graduated income tax fails. One of the legislators described, what I would call a very likely scenario, that the General Assembly would be forced to raise the current flat tax to a higher

amount, which would apply to everyone. One of the legislators, I assume in referring to polling, said that while the amendment would likely pass in our area, at least at this time it was not as popular in downstate Illinois.

What I learned from legislators at my IRTA luncheon.

My Illinois Retired Teachers Association chapter usually has a lunch with legislators and candidates in an election year. Yesterday six General Assembly members, all Democrats, from this solidly blue north Chicago suburban area showed up to share their views of the past legislative session. They were nearly giddy. With large Democratic majorities in both chambers and JB Pritzker replacing Republican Bruce Rauner in the Governor's office, they all said it was a new day. Still,

some of us retired public employees in the audience continue to have concerns. After all, legislative Democrats are not immune to cutting pension benefits, if past practice is any predictor of future behavior.

My friend Conrad Floeter asked what if the vote on a constitutional amendment allowing for a progressive income tax fails to receive the super majority vote in 2020? There seems to be no plan B. What about the proposal to tax retirement savings? It seems it is a non-starter. The thing about taxing retirement income is that this isn't just aimed at public employees. It would be everybody's retirement. Those rich guys too. And there are retired voters in every legislative district that would not vote kindly on this issue.

I asked about a constitutional change to the pension protection clause. State Representative Robyn Gabel was spot on when she bluntly said that a change to the language that says public employees enrolled in a pension plan cannot have their benefits diminished or impaired would change nothing. Current members of the state pension systems would continue to receive their benefits and without additional revenue and a change to the ramp. She said that, not me.

I asked about Tier II state employees. Their plan is worth less than Confederate dollars and their payments are the only thing paying down the state's pension liability. And I asked about Tier III attempts to move the system to a defined contribution system. There was general silence on those issues.

AARP Tax Return Preparer, Multiple Northwest Suburban Locations

Tax Aides to work with taxpayers directly, filling out tax returns and helping them seek a refund. This service is provided for moderate and low-income taxpayers with special attention to persons age 50 and older. Both federal and state returns are prepared including 1040 with Schedules A, B, D, C within limited expenses, 1099, Schedule K-1, Health Savings Accounts and other forms. Complicated and complex returns are not accommodated.

No prior tax preparation experience is required. Volunteers must be comfortable working computers and software. Training on the latest tax preparation forms and software is required. Training dates are January 3, 10, 17, & 24, 2020 at Harper Learning and Career Center, 1375 S Wolf Rd, Prospect Heights from 9:00 to 4:00 pm. Some flexibility with on-line training is possible, if unable to attend all training days. Tax preparers must pass a test at end of training.
