Bob Lyons' Report:



TRS asks the State of Illinois for a Contribution of \$5.69 Billion

The TRS Board has asked for a contribution of \$5.69 billion for Fiscal Year 2022, an increase of 10.7% over the current year's \$5.14 billion. Our return on our investments was finally calculated

for FY 2020 ending on June 30 at 0.55%. Halfway through the fiscal year on December 31 we were up 13.4%, but the effect of COVID-19 on the market brought us down to just above breakeven. The system's unfunded liability increased by \$2.6 billion to a total of \$80.7 billion. The total liability – all benefits to all TRS members for all time is calculated to have increased by \$4.1 billion to \$135.6 billion. We ended the fiscal year with \$51.6 billion in assets.

Despite the growth of the unfunded liability in FY 2020, the funded status of TRS remained relatively stable at 40.5 percent compared to 40.6 percent in FY 2019.

Since the start of this fiscal year our fund has grown and in mid-October our fund had improved to over \$54 billion. The stock market of course has been down with the current increase in COVID cases and hospitalizations. What is important for all of us that are currently retired is that we are covered and that there is more than enough money to pay our pensions. If the Fair TaxAmendment passes on election day, the state next year will have several billions more in revenue. If Biden is the new president and the Democrats control both houses of Congress, Illinois will get additional help from the federal government. If the constitutional amendment does not pass and/or the Democrats are not successful, the State of Illinois is going to be looking for new sources of revenue.

Even with the last year, where we barely showed a profit, TRS has shown positive returns for every year in the last decade and a 40 year average of annual returns of nine percent.

As an individual who is enrolled in Medicare Parts A and B, your Annual TRAIL MAPD Open Enrollment Period will be held in the fall of each year. The TRAIL plan year is January 1 through December 31. The Open Enrollment Period is from October 15 - November 16.

Many enrollees have been calling the IRTA asking questions concerning the open enrollment process. Please read the information sent to you thoroughly.

IMPORTANT INFORMATION

- Materials sent to you from the TRIP sponsored TRAIL MAPD plan administrators will feature the TRAIL logo
- If you are currently enrolled in one of the TRAIL plans, your coverage will continue you do not need to do anything unless you want to make a change.

Yesterday, October 27th, TRS held its first stakeholder meeting in several years. The web meeting had several presentations by the TRS staff and Chairman Devon Bruce opened the meeting. The following is a summary of the staffs' presentations:

- TRS staff shifted to remote work in March.
- TRS staff transition back to the office in July. A maximum of 50% of the staff is physically at the office daily.
- May 3, 2021, there will be an election for two teacher trustees & one annuitant.
- Candidate nominations require 500 valid handwritten or electronic signatures.
- Electronic signatures are a new option available due to COVID 19.
- The pandemic magnified already volatile stock markets globally.
- TRS took a defensive posture designed to protect assets within difficult market environments.
- TRS's goal is to maximize expected return with a prudent level of risk.
- Fiscal Year 2020 membership 163,115 active members. (Tier 1 112,004; Tier 2 51,111).
- There are 125,927 annuitants/beneficiaries.
- The oldest retiree is 109 years old.
- The oldest active teacher is 81 years old.
- The average monthly benefit for recipients is \$5,027.
- Assets as of June 30, 2020 are \$54.9 billion.
- Funded ratio 40.5%.

The IRTA will be sending a link to our members Monday, November 2nd to sign the IRTA endorsed TRS Annuitant candidate, Larry Pfeiffer's petition.

In this year of pandemic, that's especially difficult since units have had a serious challenge in contacting 2020 retirees, as well as inviting them to meetings that can't be held. Every IRTA member who knows a new retiree needs to make contact and invite them to join IRTA. Be sure to impress on them, that we are the only state organization solely dedicated to protecting and preserving our state benefits, just as we have done in the past and will always do in the future.
