Bob Lyons' TRS Report



I will assume you are familiar with the concept that a successful retirement plan is like a "three legged stool:" It would feature social security, your personal savings well invested, and a pension plan. Sadly, according to the National Institute on Retirement Security it is a rare individual today that

has all three. Actually, they say that it is less than ten percent of Americans. For many people their monthly Social Security payment is the only thing that they can count on. And for many others it is the largest part of their retirement income. Retire at 65 today and your first check is going to be at the very most \$3,200, or a little over \$38,000 a year. And that is not the average, that is the high end. The average Social Security is closer to \$18,000 a year. The problem for many is that, not only that they do not have a pension, but that they also spend pretty much all that they earn, so that they have little savings.

For Americans in the private sector that do have a pension it is far more likely to be a *defined contribution pension*.

Meaning that what you have when you retire is going to entirely depend on what have you saved and invested. When you retire you have a lump sum. Live too long and it is gone. You will live on Social Security for your last years.

The kind of pension that Illinois retired teachers have is a *defined benefit* pension. What your pension will give you, what you will have to live on for the rest of you life, you will know when you retire. Our pension fund was recently worth more \$62 billion, and though it was only 42 percent funded; what is important is that you will receive your pension check every month, every year, and that is guaranteed. It has also grown at a compound rate of 3% per year. While that is less than the current rate of inflation, a growth rate of 3% per year is significantly more than the average annual rate of inflation since 1990 when that benefit first went into effect. We are significantly ahead.

I would estimate the annual current teacher pension in Illinois is about \$60,000, I will assume that almost all of you taught all, or most all of your career here in the northwest suburbs. I started teaching in 1962 at Barrington High School and I was happy to make \$4,900. There was a fellow I taught with that had started teaching in Iowa and he said the year he left he made \$3,700 "and produce". The kids would bring in corn and other vegetables for the staff. Of course to put my starting salary in perspective, gasoline was 25 cents a gallon and our apartment rent was \$95 a month. I retired from Hoffman Estates High School in 1994 taking advantage of the State's early retirement program "Five plus Five". I understand that the current starting salary for District 211 is a little more than \$58,000 and the recently approved new contract calls for the starting salary for 2023 to be \$60,000. When I was on the TRS board, I spoke to retired teachers throughout the northern half of our state. I would often ask what was the top of the pay scale for the area. I can tell you that five years ago there were a number of school districts that would not have had any teachers making the income that teachers in District 211 were starting at. Personally I think that is wrong, but it is a byproduct of our education system which is based on local control and local funding. We benefitted from good pay and well-funded schools to a degree that most of the rest do not enjoy. Of course everything here is based on our pensions being Tier One. The teachers hired after the start of 2011 are Tier Two.
